# Bob Mengle- Resident

Mr. Mengle reported it has been brought to his attention the concerns of violence happening inside the schools, including the high school and junior high. He talked about a teacher being hurt and asked if the teacher was okay. Mr. Hyneman advised this is not something the Board would be commenting on and the Superintendent may want to respond. Dr. Macharola advised Mr. Mengle that the teacher is fine.

Mr. Mengle discussed the videos that were given to him and advised they are appalling and offensive. He spoke about being involved in the school district for thirty years and now is being told violence is occuring on a daily basis and that the teachers don't feel safe sometimes. He spoke about a video given to him of a student dragged down the second flight of steps and then beaten up by another student. He questioned whether the two students involved in the assault of a staff member were arrested. Mr. Boland advised this is not suitable for discussion. Mr. Mengle understood.

Mr. Mengle discussed being appalled that this is what Muhlenberg has come to and that the standards are high. He spoke about the teachers just wanting to teach and if they cannot teach the students that want to learn are then disrupted with the students that want to "act out like hooligans"; advising they must be removed from the school permanently by being expelled. He spoke about the language that was used in the video was unbelievable; and spoke about how he would be called a racist if he used those words. He reiterated he saw the video and he has the video. Mr. Mengle talked about when a student is dragging another student down the stairs, calling him names because the student is of another color; this is wrong. He spoke about this being a place for education and his background in the police force. He talked about his support for the teachers, being a union supporter, and he wants those students causing the issues out of the school.

Dr. Macharola spoke about Mr. Mengle has worn a uniform for the military and as a police officer and how much respect he has for him. Dr. Macharola advised he is not upset with Mr. Mengle's comments, and talked about how what he is saying is only "echoing" what the District has been saying here for years. He spoke about the main thing everyone must remember is that no one tolerates the violence and has zero tolerance for racism. He talked about a community here at one time that supported the disgusting, outrageous statements from a former township commissioner. Dr. Macharola reiterated there is zero tolerance for any racist comments or actions. He stated schools reflect society, it is not Muhlenberg School District; this is the community that we live in. He spoke about this being the people that inhabit the community. This is the behavior that everyone sees, however this is not the majority. He talked about this being a small group of students that are getting into the kind of problems that the District has and it's habitual. He talked about the District following board policy and federal laws that protect children with intellectual disabilities. Dr. Macharola spoke about discipline and having separate charges brought against someone is separate from what the District does; if there is an assault in this district it is highly encouraged that the police department files charges. He reiterated this is separate from the discipline; not congruent with each other. Dr. Macharola talked about knowing there are issues and this is the reason the District hired School Resource Officers; police officers armed in the high school and in the junior high. He talked about having hopes of getting two more officers in the remaining school

buildings. Dr. Macharola spoke about not needing a Board that goes behind and undermines the administrators that are very much trying to carry out the policy that has been adopted by the Board. He advised no board members should be playing politics with parents. He spoke about coming together with everyone recognizing the issues as it's a cultural problem and it's environmental. Dr. Macharola advised the Board will continue to support the administrators and teachers when it comes to following policy; keeping the litigation side of it separate. He talked about nobody wanting the District's teachers hurt; this is the job that is chosen. He also spoke about Muhlenberg School District being an urban school district; discussing this may not be the place for everyone to teach but this is a place for someone who really cares about the children, wants to get into the game and has a very high level craft to deliver. Dr. Macharola spoke about when the kids engage, these behaviors will begin to diminish. Dr. Macharola talked about no one wanting grievances filed, the District has very few filed over the last ten years and most of it is handled before getting there. He spoke about no one wanting teachers to get assaulted and even administrators that put themselves in the middle as a last resort to break up a fight. Dr. Macharola advised Mr. Mengle that a lot of the problems that he is hearing about and the films that he sees, so do thousands of others. He talked about the kids taking pictures, then sending it out and it going haywire. He advised other schools having the same issues: problems that are on the outside being brought here into the school. He spoke about how the teachers, social workers, certified behavior specialist are engaging daily with these parents and with the families trying to find better ways for them to communicate; better ways to get along with their neighbors. Dr. Macharola spoke about some of the fights that everyone is aware of is occurring because the parents are doing drugs out there and now the District has a problem with the kids coming in here trying to solve their issues. He talked about how passionate he is about these concerns and how everyone in the District is working on the issues. Dr. Macharola spoke about getting help from the community.

Mr. Hyneman spoke about his time working in Allentown School District and issues that occurred while being there. He talked about not wanting this District to become problematic and Dr. Macharola is doing everything he can to make things better.

Mrs. Eagle stated that she works in another district and she is not negating what anyone is saying, but these concerns are happening all over and are frustrating at every level.

Ms. Howard stated that she is a clinical social worker across three different counties, Chester, Montgomery, and Berks; she would like to bring attention to the fact that what our society is facing is a multi-systemic issue. She explained it is not just the school district; it's the justice department, the family court system, all of these things are working together along with Children and Youth Services.

Mr. Hoffmaster talked about being on the Board for 37 years, currently the District has the best administrators and they do everything they can to discipline and take care of the students and staff. He spoke about being notified of issues, but not everything can be discussed. Mr. Hoffmaster talked about parents, and working on the issues at home.

Dr. Macharola and the Board thanked Mr. Mengle for his comments.
