1. Describe the host's educational oversight to ensure students with disabilities are educated in the least restrictive environment while in the 1306 facility? (If not a host, answer as if you were.)

The Muhlenberg School District does not currently host any 1306 facilities, however, if the District were to host a 1306 facility, we would immediately assign a Special Education administrator from the District to the facility to provide administrative oversight for students with disabilities at the facility. This person would attend IEP meetings as the LEA, and work directly with facility staff and families to ensure that all students with disabilities at the facility were being educated in the Least Restrictive Environment. Students with disabilities who require educational placement in a Muhlenberg School District classroom, while residing in the 1306 facility, would be admitted, educated, and transported to and from the 1306 facility as required by the student's IEP.

2. Describe the district's procedures for communicating with 1306 facilities and how the district ensures a successful transition back to school?

When a student with a disability from the District is placed in a 1306 facility, the District immediately transfers any and all Special Education records to the facility, so that the student can continue to receive appropriate Special Education services while at the 1306 facility. A representative from the District attends and participates in any IEP meetings for the student, works with the facility and family to ensure that the student continues to receive services in the LRE, and plans for the eventual return of the student to the District.

Least Restrictive Environment

1. Review the district's data for Least Restrictive Environment. Highlight areas of improvement.

Review of the Penn Data SEDR for the 19-20 SY reveals that the Muhlenberg School District had 75% of students with IEP's in the greater than 80% of the time category. This compares favorably to the State average of 61.5%. The District also compared favorably to the State average for students with IEP's in the Less than 40% of time category, with MSD at 5.7% and the State at 9.6%. The final category from the Penn Data SEDR is Special Education in other settings. The District had 2.8% of students with IEP's in placements, compared to 4.8% at the State level. While the District compared favorably in all 3 categories, we can continue to improve in all areas. Having more students with IEP's being educated with non-disabled peers is always a goal for the Department at Muhlenberg. Additionally, reducing the number of students who receive educational services outside of the District is another goal as well.

2. What universal practices does the district utilize to address the academic and social/emotional needs of all students in need of accommodations to their learning environments?

The universal practice that the Muhlenberg School District utilizes is frequent team meetings. A group of professionals in partnership with the student and their family meets and makes decisions based on the available data about the student and what programs, services, accommodations, and modifications individual students need to make meaningful educational progress. This group will vary depending on the student's needs, age, and abilities, but the student is always the center of discussion.

3. Describe the academic programming and training efforts the LEA utilizes to ensure meaningful participation of students with disabilities in the general education curriculum.

The Muhlenberg School District trains all staff on a number of best practices in including students with disabilities in the general education curriculum. Staff receive training on Co-Teaching, Accommodations and Modifications, PA Grade Level Standards, and Alternate Standards. Staff also receive frequent training in a number of the best practices for instruction of students with disabilities in general education classrooms including Differentiation, Direct Instruction, and Higher Level Questioning.

4. Describe the supplementary aids and services the LEA utilizes to ensure meaningful participation of students with disabilities in extracurricular activities.

The Muhlenberg School District employs a number of SAS throughout the school district. We have over 45 paraprofessionals working throughout the District in self-contained Special Education classrooms for Life Skills and Autistic Support and other para's work in Learning Support classrooms and/or general education classrooms to support students with disabilities. The District uses the IEP process to ensure that each student with a disability is provided with appropriate SAS throughout their school career.

5. Describe the District procedures, which ensure that, to the maximum extent appropriate, children with disabilities placed in private institutions are educated with non-disabled children and have the opportunity to participate in district lead extracurricular activities?

Students with disabilities who are placed outside of District classrooms are monitored by a Special Education Coordinator from the building in which they would attend if they were at Muhlenberg. The Special Education Coordinator and the Special Education Supervisor attend IEP meetings for these students and ensure that they are being provided with quality services and participating with general education peers to the maximum extent appropriate. These staff members also participate in any discharge/return to District planning and ensure that the student returning to Muhlenberg is a positive experience.

6. Discuss the district's need to build capacity and expand programs and services in an effort to provide a continuum of services. (Consider the out of district placement chart)

The majority of the students in local, outside placements are there temporarily because of a Board Approved expulsion. Those students with disabilities who are expelled must continue to receive educational services and those students are served in those facilities for the length of the expulsion. The District

could expand its capacity to service the low incidence classrooms of Life Skills and MDS. We are finding that placement of these students is becoming more necessary, as the severity of the students medical conditions, is such that placement at the facility is necessary to provide appropriate services to the students.

1. How does the district support the emotional, social needs of students with disabilities?

Students with disabilities are supported by the Muhlenberg School District through a variety of programs and services. Each school building is staffed with 3 school counselors and 1 School Social Worker. These mental health professionals, along with the District Behavior Specialist ensure that all students receive the mental health support that they need in school. Students with disabilities who may require more behavioral or emotional support may receive social skills instruction, counseling services, and possibly a Positive Behavior Support Plan designed to change the behavior of the student.

2. Describe training provided to staff in the use of positive behavior supports, de-escalation techniques and responses to behavior that may require immediate intervention.

All staff are trained yearly in verbal de-escalation techniques, either through the Safety Care training programming or through District run PD opportunities. In the case of behavioral emergencies, all school buildings use a Standard Response Protocol. Depending on the nature of the situation, either SAM crisis services are called and/or EMS are dispatched.

3. Describe the district positive school wide support programs.

The Muhlenberg School District uses School Wide Positive Behavior Support programs at each of the 4 school buildings. The Muhlenberg Elementary Center utilizes a full SWPBS for all students called "High Five". Students earn points in the 5 areas and are given tickets by any and all staff members when a student is demonstrating the appropriate behavior. Students can use the HF points to buy items at the school store and for other incentives throughout the school year. Each of our buildings uses a similar method, with each building being more developmentally appropriate with its SWPBS.

4. Describe the district school-based behavior health services.

The Muhlenberg School District has established a District Wide Mental Health Curriculum that all students receive in all grades. The District also employs a Behavior Intervention Specialist, as well as 4 School Social Workers. These professionals oversee and deliver mental health services to all our students. The District contracts with the Caron Foundation to provide SAP and ESAP services in each of our school buildings and the District also contracts with Malvern Behavioral Health to provide counseling services in our school buildings.

5. Describe the district restraint procedure.

The District follows restraint policies and procedures as outlined in State and Federal Law. If a student is restrained, the student and any staff members involved in the physical restraint are examined by the School Nurse when safe to do so. The student's parents are notified and all available information is shared. If the student has an IEP, the restraint is reported to the RISC system, and an IEP meeting is offered to the family. If the student is not yet identified, a school team meeting is held and discussion of possible referral for Special Education services is discussed.

Intensive Interagency

Please address any areas of concern with students who are placed on Instruction Conducted in the Home or who are at a substantial risk of waiting more than 30 days for an appropriate educational placement.

When we have a student who qualifies for Intensive Interagency, we follow the PDE BSE procedures. We complete the Intensive Interagency Initial Report (and updates when applicable). If we are unable to find a placement, we will work with PaTTAN and the BCIU in order to obtain a location. We work collaboratively with another district, with our IU, with another IU, with PaTTAN, with an approved private school. At our monthly BASE meetings (Berks Administrators of Special Education), colleagues share any students they may encounter that may need special placements and the situation is reviewed and experiences shared. Our district requests local interagency team consultation through Berks County Children and Adolescent Service System Program (CASSP). When it is apparent that a student is at risk of waiting more than 30 days for appropriate educational placement, the situation is immediately reported to the state Intensive Interagency Coordinator. Our district Special Education Supervisor reports any students for whom appropriate educational placement appears to be unavailable or unlikely to the State Intensive Interagency Coordinator. The Special Education Director and Supervisor attends Berks Association of Special Education Administrator (BASE) meetings and receives training regarding any changes in the interagency approach on an annual basis. On a regular basis and when the need arises, the school district evaluates the programmatic needs of the students and uses interagency approach situation to improve LEA capacity. We have engaged in collaboration with Service Access and Management (Berks County MH/MR), Berks County Children and Youth Services, Berks County Juvenile Probation, Drug and Alcohol Treatment Programs, Office of Vocational Rehabilitation, Caron Foundation, Progressions, Reading Hospital Mental Illness Substance Abuse Programs, and our district's Student Assistance Program. The school district has not had difficulty placing students, however there are a limited number of alternative educational programs for students. The school district monitors the progress of homebound students through on-going data collection provided by the homebound instruction(s). We meet monthly with all special education administrators and the IU team. The district has the opportunity to discuss general concerns with partnering districts about the students that have needs difficult to meet. The District does not have any specific plans in place to expand the continuum of services for Hard to Place students, however we have been in discussion with some of our neighboring districts about a number of trauma informed programs that use a classroom or classrooms within a District building to provide services to students who have experienced trauma within their home school and not place them outside the District. Space within any of the District's buildings is an issue with bringing in one of these programs, along with the start up costs of running the program. Many of the District's eligible students who are placed in outside facilities have serious mental health issues that require a higher level of care than can be provided by education staffing. The District has been training all staff on Youth Mental Health First Aid and how to recognize and respond to students presenting with possible mental health issues. That training will continue through the life of this plan. As a specific student situation arises, the IEP team including the Berks County CASSP coordinator, meet to discuss any unmet needs and make informed programmatic decisions that are appropriate for the student.
