Melissa Carroll- Muhlenberg Community Library

Ms. Carroll introduced herself as the Director of the Muhlenberg Community Library. She discussed events coming up for the library in December such as the Holiday Open House which is this weekend from 11AM-1PM at the library itself. There will be Santa, a train running, snacks, goodies and crafts. The Trail of Lights will be held on December 14th which is \$25 for a whole car, lots of stops and will receive goodies along the way. Once you get back to the library everyone will have a chance to win a whole big bouquet of lottery tickets. There will be a Margherita Pizzeria fundraiser on Tuesday, December 10th. The library is starting a mental health awareness program after everything that has happened recently in the area and obviously affecting the kids. It's important to the library to start the program as they are working with a couple different people and will start in December. Ms. Caroll advised that she would like to work with Mr. Skeete at some point to be able to pass all this information on to the teens.

Questions/Comments/Concerns:

Dr. Macharola discussed having this nice conversation with Ms. Carroll regarding this program and the answer is yes as the District cannot do enough when it comes to providing services for the children and the community. Dr. Macahrola also advised he hopes this not only helps the children but also branches into helping the parents as well. Ms. Carroll advised there will be programs for parents as well. Dr. Macharola advised the need for mental health services family wide is growing at an expeditiously high rate here in the District. Not only does he want the principals and administrators to build a bridge with the library, but also the Behavioral Specialist and social workers, the district wants to keep a very open broad openness that the District does not lose anybody or someone falls through the cracks. Dr. Macharola is excited about the mental health awareness program at the library and he knows that with the professionals in the District, it will be a win-win. Ms. Carroll also advised they opened a community care closet that is open to everyone in the community, teens and adults. Ms Carroll also thanked Mr. Patterson and his team for helping finish the final renovations at the library. Dr. Macharola took time to thank Ms. Carroll and the entire library staff for their openness and their distinguished level of service; continuing to partner with the library will only make the community better and a great place to raise children.
