Yesterday, the Commonwealth Court issued a decision overruling Acting Secretary Beam's school mask order. The state is filing an appeal which may lead to a stay of the court's ruling in keeping the order in effect.

The Muhlenberg School District will continue to adhere to the school masking order for the safety of our children and adults. The district will continue to monitor the court proceedings should any action need to be considered or addressed.

Masking is addressed in our district's Pandemic Plan which you can find on our website. We as a district, will continue to observe the recommendations of the Centers of Disease Control and Prevention, the Pennsylvania Department of Health, and the American Academy of Pediatrics.
