A. Berks County Intermediate Unit - Mr. Miguel Vazquez

There is no report at this time.

B. Reading-Muhlenberg CTC – Mrs. Cindy Mengle (Mr. Joseph A. Lupia, Jr.)

Mr. Lupia advised the meeting was uneventful however they did discuss the steel/welding building that will start the payments, Muhlenberg School District's share of those payments; the District is just paying interest now.

Questions/Comments/Concerns:

Mr. Voit questioned where they were at regarding re-instituting the authority since lapsing. Mr. Hoffmaster advised that this is in progress. Mr. Boland advised he will follow up. Mr. Lupia advised they are having a career day at RACC at the Miller Center on May 1st.

C. Berks County Tax Collection Committee - Mr. Shane M. Mathias, CPA

Mr. Mathias advised that they did get their December 31 audit report from the last calendar year which was a "clean" report.

D. PSBA Liaison - Mr. Otto W. Voit, III

There is no report at this time.

E. Muhlenberg Community Library - Ms. Janet Howard

Ms. Howard advised that the library is very excited that the roof project is well underway. Ms. Howard reminded everyone that the photo exhibit for Judge Patton continues on until May 6, 2023. She reported there are some fundraisers coming up April 19th is Panera Bread, April 24th-28th is Chik-Fil-A, and May 3rd is Pizza Como; all to support the library.

F. Educational Programs – Dr. Alan S. Futrick

Dr. Futrick spoke about some updates; on April 5th the District celebrated Paraprofessional Appreciation Day; there are 52 paraprofessionals in the District and certainly wanted to thank them and recognize them for their commitment to the students and to the District's schools. He talked about at the high school there were three students; Kayla Yoder, Skylar Koch, and Dalhendji Henly attended the Women in Mathematics, Science and Technology Conference that was at Millersville University and had the opportunity to speak with one of the professors from MIT and really hope to inspire them in taking on a career in sciences. Also at the high school, through the Aevidum Club, the students spent time participating in a Healthy Relationship Campaign who the Aevidum Club has been working with to get the students to understand how crucial it is to have positive relationships in their life. He spoke about the students participating in the Art Show at the GoggleWorks. Dr. Futrick advised the BCIU to help run the show and the District had at least thirty students participate. He asked everyone to stop by to see the impressive work and spoke highly of the District's art teachers and are appreciative of their work with the students. Dr. Futrick talked about how the District's music teachers hosted the Berks County All-Star Jazz Band, four of the District's students participated in the competition and actually became members of the jazz band: Asher Landrum, Dante Fioravanti, Gianna Squitieri and AJ Rhan. Dr. Futrick spoke about the junior high science fair; the District had six students placed in the fair: Addison Helman, Logan Weidenhammer, Madison Crater, Aiden Bellanca, Christian Schmehl, and Kara Moore all placed in the science fair. Dr. Futrick spoke about Mrs. Eagle attended an elementary field trip as a chaperone at the Crayola Factory with first grade students from MEC. Dr. Futrick spoke about the District posting for Kindergarten registration on-line, any family that registers before May 5th will be invited for a special Muhl Night on May 18th where the student received a backpack full of supplies, be able to get ready for Kindergarten throughout the summer and also get to meet their Kindergarten teacher. He encouraged families to start

registering early for Kindergarten as historically the District had families sign up in August. He also discussed being able to invite the new Kindergarten to Summer Style and have the opportunity for their teacher to meet with them for a full week to orient the students prior to walking into Kindergarten; making the Kindergarten year go a lot smoother.

Questions/Comments/Concerns:

Mrs. Eagle spoke about the field trip being after the day of the school shooting, everyone feeling a little "beat up." She spoke about how the students did not have electronics, as she is used to her high school students all having them, so the bus was loud. She explained at first she took a minute to reflect and the students started playing games like "I Spy" and it truly became one of those "feel good" moments; just kids being kids. Mrs. Eagle pointed out that the kids were being so kind to each other and this is a reflection of what the staff is doing with them at the elementary level. She commented how "refreshing" it was to experience it.

Solicitor's Comments - Mr. Brian F. Boland, Esq.

There is no report at this time.

Superintendent's Comments - Dr. Joseph E. Macharola

Dr. Macharola thanked everyone for their updates on the students and things going in the school district. He spoke about Skyler Koch, received an award and honored by Berks County's top high school senior girl from the American Association University Women and there is so much to say about her and also participated in the MIT event at Millersville University. Dr. Macharola thanked everyone in the administration and District for their phenomenal work. He spoke about an article he sent out regarding Pennsylvania issued the lowest number ever of new teaching certificates as the education shortage worsens; that also means that there aren't enough teachers that want to become administrators. He discussed being a leader in education today takes quite a bit, not only from personal welfare, educational background and the desire to do it, but also to be effective as a school leader. He talked about needing great people here to work, he talked about being proud of the District's instructional coaches working with the teachers now, as the District needs them more than ever. Dr. Macharola spoke about for the District to "attract" great people with the professional development that the District currently has to offer, the District has to get the "good message" out there. Dr. Macharola talked about a disturbing conversion he recently had with a parent today as he did not like the comments this parent was making. He addressed his concern and affirmed the District does not make drugs in the Muhlenberg High School or the Junior High or any building. Dr. Macharola talked about the Muhlenberg School District being a phenomenal school district, a U.S. News and World Report school system and the District has done right here. He spoke about how the Board has dedicated themselves and committed itself and has "put its money where its mouth is" and there is no better school district that he has worked for. He emphasized that the District does not entertain negativity here. He discussed schools reflecting society,

society does not reflect the school. Dr. Macharola reiterated the District does not condone drug activity here, and this was such a disturbing comment and a poor reflection of that parent. He talked about the District doing everything possible to keep the students and staff safe.
