Committee Report

A. Berks County Intermediate Unit – Mr. Miguel Vazquez

There is no report at this time.

B. Reading-Muhlenberg CTC – Mrs. Cindy Mengle

Ms. Mengle advised they had their meeting on Monday night; the first thing that was discussed was on May 1st, they had their first Berks County Decision Day at RACC and that was for CTC students who were going to the military, going to the workforce, or going to college. She talked about how nice it was that with those going into the workforce, some of their employers were present. Mrs. Mengle reported next year there will be 527 new students which will be a total of 1,244 total students for next year; just a handful more than what there is now. Also on May 30th, here in the District's auditorium there is going to be the Senior Recognition Night. She advised they will be switching between Reading and Muhlenberg every year, so this year it will be Muhlenberg. She advised she is looking forward to having everyone in the District's auditorium.

C. Berks County Tax Collection Committee - Mr. Shane M. Mathias, CPA

There is no report at this time.

There is no report at this time.

E. Muhlenberg Community Library - Ms. Janet Howard

Ms. Howard advised that the library had their monthly board meeting this past Monday. Upcoming events, today was the Austin's and Coastal Grille fundraiser, May 17th is with Five Stars Nutrition as a portion of those proceeds will go to the library, and Friday night is Paint and Sip. She informed they still have tickets available, however there is a need to purchase them prior to the event on Friday night.

F. Educational Programs - Dr. Alan S. Futrick

Dr. Futrick talked about Teacher Appreciation Week and wanted to take a moment to thank all of the District's wonderful teachers. He thanked them for their commitment to the students and all the energy and enthusiasm they bring to the classroom each and every day to make a difference in the lives of the students. Dr. Futrick advised as they always say, "People make the difference and teachers do make a difference." He discussed something new that the District is doing, regarding Instagram over the last few months; this year for all of the District's seniors there will be a picture of each senior posted, in cap and gown and asked them a few questions such as favorite teachers, favorite school memories. He asked everyone to take a moment to see what they have been bringing to social media. Dr. Futrick also advised the District sent out messages to the senior parents and they can write a message with their kid's picture. The picture could be when they were younger, and the nice message from the parent has really bought a lot of engagement from the He spoke about a couple of groups of the District's students volunteering at a few places; the Leo club went to Hawk Mountain last week and did a lot of cleaning up grounds and built some cots and tents. It was a very nice experience for them. The Junior High Aevidum Club went to Helping Harvest and got to prepare boxes; again another great experience as the kids were excited to be a part of that. Dr. Futrick talked about this being field trip season for a lot of the District's students, the C.E. Cole students already talked about where they were going, and advised the Junior High students recently went to Nolde Forest and really enjoyed this. Dr. Futrick commented if anyone had the opportunity last week to come out and see the Muhlympics which was a huge success; this is something all of the District's students really appreciate. He spoke about Muhlympics being such a great thing for the kids and they are rewarded for their efforts. He commented along those same lines, there is a new sport for special needs students that is starting to get some momentum in the state of Pennsylvania; right now two Berk County schools

have a team. One is a track and field team which is a combination of special needs students and regular education students; and another school has a Bocce ball team. Dr. Futrick advised the District is looking to start a unified track and field team and Mr. Vanino will be looking into this along with Ms. Huntbach; he also advised they will be looking into the Bocce ball team as well. Dr. Futrick advised these are two things that are going to be up and coming and talked about always trying to get the students involved in some type of club, sport, or activity when being here in Muhlenberg. Dr. Futrick talked about being very proud of the National Honors Society induction where about 45 students were inducted as juniors and seniors. He commented that he was very proud of the work of those students and the requirements that were met along the way to get into that honors society. Dr. Futrick spoke about the upcoming event on May 16th, the Festival of the Arts, at the elementary school as the entire building is decorated with the artwork of the District's students. He commented that the art teachers must put in at least five days of work for the setup of this program and it is an awesome experience for the families to see the work of their kids. Dr. Futrick talked about the recent Career Fair at the high school last week which very well attended. He explained this was for the seniors who got to meet a lot of local companies who are looking to hire and also educate the kids who are interested in going to higher education or going into the workforce. He advised about two dozen companies attended the event and also Dr. Heffner participated in it. Dr. Futrick also spoke about Dr. Macharola earning his junior pilot's license and joked about his experience.

Questions/Comments/Concerns:

Mrs. Eagle spoke about having the Unified Bocce at Governor Mifflin school and advised it is absolutely amazing to watch these athletes, and the student body showed more for this than other sporting events. She commented that it is the coolest thing to see.

Dr. Futrick reiterated that when seeing the enthusiasm, it is the same thing that Muhlympics does bring: enthusiasm.

Dr. Macharola spoke about his recent experience with flying with Col. Riley. He talked about getting to experience what the District's students get to experience. He advised he had a great time despite having a little bit of turbulence; he was grateful for the opportunity.

Mrs. Eagle also wanted to take a moment to thank the teachers as they do not realize how much of an impact they have on their students.

Solicitor's Comments - Mr. Brian F. Boland, Esq.

Superintendent's Comments - Dr. Joseph E. Macharola

Dr. Macharola talked about June 7th graduation, will be graduating 377 students; ten years ago it was 270 students and are really excited about the direction the school district is going. He talked about it being teacher appreciation week but he also has sent out a picture from nine years ago with children from a board meeting. He mentioned the children in the picture are now graduating. He spoke about how much the district has changed and a lot to be thankful for. Dr. Macharola spoke about how proud of the library being here and spoke about some funds coming as he has had some meetings with Representative Rozzi. He spoke about "earmarking" funds coming in for the police department, not knowing how substantial the amount will be however possibly \$200,000. He discussed the District already having its budget, though this would help. He also discussed hopefully having some extra money for the library as the library is struggling financially; which is why all the fundraising is needed. He discussed the District doing a lot of things for the community, especially with the District's students going over to the library. He talked about the library always being "synonymous" with the District despite being a public library. He talked about working on cleaning up the building, getting new signage and making it look like it belongs on campus. He spoke about Dr. Futrick doing a phenomenal job talking about all the wonderful things the District is doing and thanked everyone.
