Updated COVID-19 Measures

On behalf of Superintendent, Dr. Joseph E. Macharola, this message serves as an organizational update regarding updated measures from the Governor's Office and the Pennsylvania Department of Health (DOH) relating to COVID-19.

On Monday, November 23, 2020, Governor Wolf and Secretary of Health Dr. Rachel Levine issued a press release announcing targeted mitigation measures to help stop the spread of COVID-19 during this critical time. While the directives are applicable to an array of organizations (businesses, recreational facilities, restaurants, etc.), specifics for educational entities are a part of this order. Three areas that impact the Muhlenberg School District and the Pennsylvania Key are as follows:

- 1. Our Health and Safety Plan can be viewed on the District website.
- 2. As part of the mitigation efforts, public schools (identified as a school district, intermediate unit, charter school, cyber charter school, or a career and technology education center) in substantial transmission must complete an attestation process to affirm that they are complying with the following orders:
  - o Recommendations for Pre-K to 12 Schools Following Identification of a Case(s) of COVID-19, when cases of COVID-19 occur within the school entity.
  - O Updated Order of the Secretary of the Pennsylvania Department of Health Requiring Universal Face Coverings, effective November 18. As a reminder, the mask order includes the following:
    - Masks are required to be worn indoors and outdoors if you are away from your home.
    - When outdoors, a mask must be worn if you are not able to remain physically distant (at least 6 feet away) from someone not in your household the entire time you are outdoors.



- When indoors while at work, masks will now be required even if you are physically distant from other individuals. This means that even if you are able to be 6 feet apart, you will need to wear a mask while inside unless you work alone.
- When indoors at home with individuals not in your household, masks will now be required even if you are physically distant from the individuals not in your household. This means that even if you are able to be 6 feet apart, you will need to wear a mask while inside if with people other than members of your household.
- This order applies to every indoor facility, including homes, retail establishments, gyms, doctors' offices, public transportation, and anywhere food is prepared, packaged, or served.
- o The Muhlenberg School District has completed the attestation form indicating we will continue with a virtual model of instruction with the required mitigation efforts implemented (as per the Muhlenberg School District Health and Safety Plan). As an organization, we will continue to evaluate the conditions and data related to the Muhlenberg School District COVID-19 cases and / or staffing implications. The delivery of services will be adjusted as needed to continue to prioritize the health and safety of staff, students, and the community.
- 3. The Department of Health (DOH) and the Pennsylvania Department of Education (PDE) have provided additional guidance regarding the travel testing order effective November 20 as follows:
  - o Individuals traveling into and returning to the Commonwealth of Pennsylvania from any other State or Commonwealth or an international location, must produce evidence of a negative SARS-CoV2 (COVID-19) test from a specimen collected within 72 hours prior to entering the Commonwealth, or quarantine for 14 days upon entering, unless they qualify for one of the exemptions specified in Section 4:

## Exemptions

The following individuals are exempt from this testing and quarantine order but shall conduct travel with attention to social distancing and wearing of masks when in contact with other individuals.

- a. Individuals travelling to and from the Commonwealth for the purposes of work.
- b. Individuals travelling to and from the Commonwealth for medical reasons, including individuals providing comfort and support to the patient.
- c. c. Military personnel travelling to the Commonwealth by order or directive of a state or Federal military authority.
- d. Individuals in transit through the Commonwealth to another destination, provided that the time spent in the Commonwealth is only the amount of time necessary to complete the transit, make use

- of travel services, such as a highway rest stop, or make any necessary travel connection.
- e. Additional exemptions may be issued in guidance documents issued by the Department.
