Committee Reports

A. Berks County Intermediate Unit - Mr. Randall R. Madara

Mr. Madara reported that a meeting was held in May via Zoom. There was nothing new happening. The IU is just trying to get through COVID-19 like everyone. A copy of *What Happened at the BCIU Board Meeting* was included in the packet this month.

B. Reading-Muhlenberg CTC – Mrs. Cindy L. Mengle

Mrs. Mengle reported the Committee met on Monday, June 8th. They approved Mr. Eric Kahler as the new Executive Director of the RMCTC to replace Dr. Witmer the current Executive Director. Mr. Kahler is coming from the Career Institute of Technology in Easton. He is scheduled to start on July 13th.

C. Berks County Tax Collection Committee – Mr. Shane M. Mathias/Mr. Otto W. Voit, III

Mr. Mathias said there was no meeting this month. There may be one possibly in June.

There is a meeting coming up on Monday, June 15th. The dismantling of the Fairgrounds Square Mall has begun.

G. Educational Programs – Dr. Alan S. Futrick

Dr. Futrick was excited to report that each year the District's ELL students take the WIDA test, which is a basic measurement of their understanding and comprehension of the English language. Last year, 112 students took the assessment and 63 of those students that took the test last year showed growth from one year to the next, which is 56%. He said at the end of last school year and during the budget process, Dr. Macharola asked the school board to hire three new ELL teachers for the 2019-2020 school year; and, he said he was very pleased to report that this year the District had 173 students take the assessment and 133 of those students (or 77%) showed growth. Dr. Futrick thanked Dr. Macharola for his leadership and he thanked the school board for approving those positions because it is clear to see that there was a 20% increase in the students' vocabulary, understanding and comprehension of the English language. He applauded the ELL teachers for their support, instruction and guidance with students and they are certainly making a difference.

Comments/Questions/Concerns:

Mr. Lupia asked if students were still coming into the District at the level of not knowing English or is there a plateau now of students who do not know English. Dr. Futrick replied the District is always getting students who have very little understanding of English. He said it is not just first grade or second grade. The District has high school students that are moving here and enrolling into the schools that do not have an understanding of the English language. Dr. Futrick said the District was very fortunate to be able to increase its ELL staff.

Solicitor's Comments

There was none.

Superintendent's Comments - Dr. Joseph Macharola

Dr. Macharola reported that graduation would be held June 18th at 10:00 AM at the high school on the parking lot; and, the rain date would be June 19th. Parents received an update notifying them of some modifications to the original plan to better serve students so that everyone would be able to enjoy graduation together. He said there would be social distancing under the yellow phase; and, students and their families will be given the best graduation possible given the challenges everyone has faced over the past few months with COVID-19. Dr. Macharola said it would be the kind of graduation that a student will never forget. He said the community hosted a parade for seniors and it was wonderful to see parents out. The school will give the students a graduation that they truly deserve. Dr. Macharola said he heard people say, "Muhlenberg has decided to have a graduation"; but he said, that was not true - Muhlenberg was always going to have a graduation. It just changed as things changed with COVID-19. He said now that the county has gone from red to yellow and stepped into another realm, which is safer for everybody at least in terms of where the District is with its own practices. This will be a great day for the seniors and Dr. Macharola said he was very excited for graduation. He said he thinks it will be a really great ending for students. Dr. Macharola thanked Mr. Mish, Mr. Schaeffer, Ms. Morris, all of the staff and faculty, other principals, Dr. Futrick and administrators that assisted in putting this together. He complimented Mr. Mish for all of his cooperation and loyalty working his way through some very difficult times through all of this. Dr. Macharola said they kept the aircraft carrier going in the right direction and tried to do what was right and will continue to do what is right. He said God Bless the seniors and he was looking forward to June 18th. It will not be the same as the Santander but it will be something really unique and something they will never forget. Dr. Macharola said he thought it was a good thing and he was very happy for them.

Dr. Macharola said the District has been putting out 700 meals a week and will continue to do so as needed for the community. He said he is very proud of Mr. Carey Kline. He and the cafeteria workers have been doing a phenomenal job.

Dr. Macharola said the District had 170 additional mental health concerns (50 of those were immediate) over the last two weeks. The District is continuing to do welfare check-ins, addressing academic concerns, post-secondary concerns and scheduling options. Mr. Milch, the District's Behavior Specialist, all of the counselors (elementary, intermediate, middle and high school) are reaching out to students. Dr. Macharola said if anyone is feeling depressed or feeling helpless to please know the District was there to help – reach out because there are organizations and agencies that can help. Dr. Macharola said he mentions this every month because it is very serious and the numbers keep increasing and he does not want anyone lost. Dr. Macharola said just a note on the civil unrest coupling at the same time with COVID-19, there is nothing more wrong than the death of Mr. Floyd. He said his heart ached for his family and for the community.

He said the Muhlenberg School District respected diversity. Dr. Macharola said the District will be good listeners and there is a lot of work to be done. He said with that in mind, June 6th was D-Day and he could not help to think of all of the civil unrest on that day. He said it meant so much for the sacrifices of 1944 so that everyone has freedoms in this country – freedoms that Americans enjoy and the freedoms that are expected, but they will be challenged as time goes on. Everyone needs to come together just as generations did in the past; everyone needs to come together for the future, but in a much different way with respect for everyone. Dr. Macharola said for all of the veterans, especially with June 6th just passing, those who gave so much (the ultimate sacrifice), and may we still have those people today that will step up and give so much in whatever capacity possible so that we can have a better America and a better world.

212 2020-2021 Homestead and Farmstead Exclusion Resolution

Resolved, by the Board of School Directors of Muhlenberg School District, that homestead and farmstead exclusion real estate tax assessment reductions are authorized for the school year beginning July 1, 2020, under the provisions of the Homestead Property Exclusion Program Act (part of Act 50 of 1998) and the Taxpayer Relief Act (Act 1 of 2006), as follows:

Resolved, by the Board of School Directors of Muhlenberg School District, that homestead and farmstead exclusion real estate tax assessment reductions are authorized for the school year beginning July 1, 2020, under the provisions of the Homestead Property Exclusion Program Act (part of Act 50 of 1998) and the Taxpayer Relief Act (Act 1 of 2006), as follows:

Aggregate amount available for homestead and farmstead real estate tax reduction. The following amounts are available for homestead and farmstead real estate tax reduction for the school year beginning July 1, 2020:

- a. <u>Gambling tax funds</u>. The Pennsylvania Department of Education (PDE) has notified the School District that PDE will pay to the School District during the school year pursuant to Act 1, 53 P.S. § 6926.505(b), as a property tax reduction allocation funded by gambling tax funds, the amount of \$1,194,920.51.
- b. Philadelphia tax credit reimbursement funds. PDE has notified the School District that PDE will pay to the School District during the school year pursuant to Act 1, 53 P.S. § 6926.324(3), as reimbursement for Philadelphia tax credits claimed against the School District earned income tax by School District resident taxpayers, the amount of \$7,160.48.
- c. **Property Tax Reduction Funds.** Funds will be available during the school year for real estate reduction as a result of undistributed funds from the property tax reduction funds received in 2019-2020. These funds will be added to the allocation for this school year in the amount of \$44.06.
- d. <u>Aggregate amount available</u>. Adding these amounts, the aggregate amount available during the school year for real estate tax reduction is \$1,202,125.05.

<u>Homestead/farmstead numbers</u>. Pursuant to Act 50, 54 Pa. C.S. § 8584(i), and Act 1, 53 P.S. § 6926.341(g)(3), the County has provided the School District with a certified report listing approved homesteads and farmsteads as follows:

- a. <u>Homestead property number</u>. The number of approved homesteads within the School District is 5,559.
- b. **Farmstead property number**. The number of approved farmsteads within the School District is 1.
- c. <u>Homestead/farmstead combined number</u>. Adding these numbers, the aggregate number of approved homesteads and farmsteads is 5,560.

Real estate tax reduction calculation. The school board has decided that the homestead exclusion amount and the farmstead exclusion amount shall be equal. Dividing the paragraph 1(d) aggregate amount available during the school year for real estate tax reduction of \$1,202,125.05 by the paragraph 2(c) aggregate number of approved homesteads and farmsteads of 5,560, before considering the assessed value of approved homesteads and approved farmsteads having an assessed value below the preliminary calculation of the maximum real estate assessed value reduction amount to be established as the homestead and farmstead exclusion amount, the preliminary calculation of the maximum real estate tax reduction amount applicable to each approved homestead and to each approved farmstead is \$216.20.

Based on calculations provided by the School District Business Office from the best available information and carefully evaluated by the School Board, considering the assessed value of approved homesteads and approved farmsteads having an assessed value below the preliminary calculation of the maximum real estate assessed value reduction amount to be established as the homestead exclusion and the farmstead exclusion amount, an additional

aggregate amount of \$433.32 will be available during the school year for real estate tax reduction applicable to approximately 5,546 homesteads and farmsteads, resulting in an additional real estate tax reduction amount available for each homestead and farmstead of \$.07. Adding this additional amount to the preliminary calculation of the maximum real estate tax reduction amount of \$216.20 the final maximum real estate tax reduction amount applicable to each approved homestead and to each approved farmstead is \$216.27.

<u>Homestead exclusion calculation</u>. Dividing the paragraph 3 maximum real estate tax reduction amount of \$216.27 by the School District real estate tax rate of 30.73 mills (.0) the maximum real estate assessed value reduction to be reflected on tax notices as a homestead exclusion for each approved homestead is 7,037 and the maximum real estate assessed value reduction to be reflected on tax notices as a farmstead exclusion for each approved farmstead is 7,037.

Homestead/farmstead exclusion authorization. The tax notice issued to the owner of each approved homestead within the School District shall reflect a homestead exclusion real estate assessed value reduction equal to the lesser of: (a) the County-established assessed value of the homestead, or (b) the paragraph 4 maximum real estate assessed value reduction of 7,037. The tax notice issued to the owner of each approved farmstead within the School District shall reflect an additional farmstead exclusion real estate assessed value reduction equal to the lesser of: (a) the County-established assessed value of the farmstead, or (b) the paragraph 4 maximum real estate assessed value reduction of 7,037. The homestead exclusion and farmstead exclusion real estate assessed value reduction will apply only to tax notices issued based on the initial tax duplicate used in issuing initial real estate tax notices for the school year, which will be issued on or promptly after July 1, and will not apply to interim real estate tax bills.

213 Adoption of Final Budget for 2020-2021 School Year

Resolved, that the Board of Education of the Muhlenberg School District adopt the 2020-2021 Final Budget as presented by the Administration. The Final Balanced Budget Expenditures total \$63,998,903; Revenues total \$62,344,572 and \$1,654,331 will be used from assigned PSERS fund balance. The millage rate of 30.73 mils depicts a .0 millage increase.

Said budget shall set forth a levy of the following tax structure: a tax of 30.73 mils (\$30.73 per \$1,000.00) of assessed market value of real estate; and the district's share of a realty transfer tax of 1%; a local services tax of \$52.00 for Laureldale and an local services tax of \$52.00 for Muhlenberg Township; a 1% earned income tax; a mercantile tax consisting of one mil on wholesale transactions; and a business privilege tax at the rate of one and one-half mils on the gross volume of business, to provide the necessary revenue for same (Exhibit #167).

Extension to the Discount Period of the 2020 School Real Estate Tax Bills

A resolution of the Board of Education of the Muhlenberg School District, Berks County, Pennsylvania, authorizing the 2020 School Real Estate Tax Bills to include four payments at face value along with a thirty (30)-day extension to the discount period as follows:

WHEREAS, pursuant to Policy 606 of the Board of School Directors of the Muhlenberg School District ("District") adopted on May 11, 2011, the District wishes to amended the tax billing and collection schedule for local real estate taxes to reflect the District's fiscal year (2020), which extends the discount period on early payment in an effort to limit financial hardship for District taxpayers, adds a fourth (4th) installment payment at face value and delays the penalty period until January 1; and

WHEREAS, the District is sympathetic to the financial hardships faced by many of the Districts' taxpayers, and has determined that the realignment of the tax collection schedule should be phased in to lessen the impact to the Districts' taxpayers.

AND NOW, THEREFORE, this 10th day of June, 2020, **BE IT HEREBY RESOLVED** by the Board of Directors of the Muhlenberg School District, the following:

- 1. **The 2020-2021 Local Real Estate Tax Collection Cycle.** For the 2020-2021 local real estate tax collection cycle:
 - a. The Administration is directed to ensure School Tax bills are printed and mailed on or before July 1, 2020.
 - b. All District taxpayers shall be entitled to a discount of 2% from the amount of School Tax due upon their making payment of the whole amount any time from the date of the tax notice until September 30, 2020.
 - c. The face amount of School Tax, with no discount nor penalty imposed, is due from October 1 until December 31.
 - d. A 10% penalty shall be imposed on the School Taxes on payment received after December 31, 2020.
 - e. Taxpayers shall have the option to pay the School Tax face amount in four equal installments. Installment payments shall be due August 31, 2020, September 30, 2020, October 31, 2020, and December 31, 2020. Payment of the first installment on or before the due date is evidence of intention to pay on the installment plan. A penalty of 10% will be added to each installment on the date it becomes delinquent.
 - f. All unpaid School Taxes as of December 31, 2020 shall be turned over to Berks County Tax Claim Bureau for collection.
 - g. The Administration is directed to ensure the District's tax collector is notified of these changes and that the District's School Tax Bill (also known as the tax notice) is modified accordingly.

- 2. The 2021-2022 and Subsequent Years Local Real Estate Tax Collection Cycle. For the 2021-2022 real estate tax collection cycle and each cycle thereafter:
 - a. The Administration is directed to ensure School Tax bills are printed and mailed on or before July 1st of each year.
 - b. All District taxpayers shall be entitled to a discount of 2% from the amount of School Tax due upon their making payment of the whole amount any time from the date of the tax notice until August 31st of each year.
 - c. The face amount of School Tax, with no discount nor penalty imposed, is due between September 1st and October 31st of each year.
 - d. A 10% penalty shall imposed on the School Taxes on taxes paid after November 1st of each year.
 - e. Taxpayers shall have the option to pay the school tax face amount in three equal installments. Installment payments shall be due July 31st, September 30th, and November 30th, of each year. Payment of the first installment on or before the due date is evidence of intention to pay on the installment plan. A penalty of 10% will be added to each installment on the date it becomes delinquent.
 - f. All unpaid school taxes as of December 31st of each year shall be turned over to Berks County Tax Claim Bureau for collection.
 - g. The Administration is directed to ensure the District's tax collector is notified of these changes and that the District's School Tax Bill (also known as the tax notice) is modified accordingly.
- 3. **Timely Payment Determination.** For all such tax collection cycles, whenever the last day of a period during which payment may be made at a discount or without penalty shall fall on Saturday or Sunday or on any day made a legal holiday by the laws of this Commonwealth or of the United States, payment shall be considered timely if it is tendered or postmarked by the United States Postal Service on the succeeding secular or business day (Exhibit #171).

Mr. Lupia said that all of his kids had Mr. Hangen. He said Mr. Hangen was very soft spoken and he always spoke highly of Mr. Lupia's children. He said all of the kids loved Mr. Hangen and they have clocks to prove it. Mr. Lupia said his kids still have their clocks and every time he looks at those clocks, he will think of Mr. Hangen. Mr. Lupia said he would be sorely missed; may he rest in peace.

Dr. Macharola asked Dr. Jeffery Ebert, Principal of Muhlenberg Middle School, to say a few words.

Dr. Ebert said he had the privilege of working with Mr. Hangen over the past four years. He said he was a humble individual. Mr. Ebert said prior to coming to Muhlenberg, another educator in the county came up to him and told him, "if you ever need something, there is one guy you can go to and he is in the middle school, Dave Hangen. Go to Dave Hangen." He said when Dr. Ulsh came on board, every teacher at the elementary center told her that if she ever needed anything, she should go to Dave Hangen. Dr. Ebert said that was the kind of man Mr. Hangen was - he was a selfless man, he put others first, himself second. He said Mr. Hangen worked tirelessly for the betterment of his kids whether it was Muhlenberg kids or his own children or athletics. Dr. Ebert said the clocks were a big thing and they meant a lot to him because it gave him the opportunity to meet with the students on a different level and develop that relationship through the hands-on machinery. He said Dave Hangen was an outstanding person. Dr. Ebert said Dr. Macharola often used the term, salt of the earth, and Dave Hangen was the salt of the earth. He said he was grateful for the chance to meet him and to work with him. Dr. Ebert said Muhlenberg lost a special one with his passing. He asked that everyone keep Mr. Hangen's family in their thoughts and prayers; and thanked Dr. Macharola and President Hardy for giving him an opportunity to speak about Mr. Hangen.
