Mr. Madara said a meeting was held November 19<sup>th</sup> and it was pretty much business as usual. He said there was nothing to report that was out of the ordinary.

B. Reading-Muhlenberg CTC - Mrs. Cindy L. Mengle

Mrs. Mengle said they did not have a meeting this month. The re-organization meeting will be held in January.

C. Berks County Tax Collection Committee - Mr. Shane M. Mathias, CPA

No report at this time.

D. PSBA Liaison - Mr. Otto W. Voit, III

Mr. Voit said the ballots would be coming out in about a week to all Board members to vote for a PSERS representative on the trustee board. He said he is the endorsed candidate for PSBA to fill that seat and he was respectfully asking for the Board's consideration and vote. Mr. Voit said the ballots will get mailed to Board members' homes.

# E. Muhlenberg Community Library - Mr. Terry Heckman

Mr. Madara said he did not have a report from Mr. Heckman. Mr. Patterson had a great report and covered what is happening with repairs at the library. He said his wife who is on the Board at the library shared that the library received a \$10,000 anonymous donation. Also, Mascaro donated \$5,000 this year and plans to donate another \$5,000 next year.

F. Muhlenberg Township/Laureldale Borough Liaison – Mr. J. Tony Lupia, Jr.

Mr. Lupia said the Parks and Recreation Board is planning a fundraiser for the library to make up for the insurance deductible. The Laureldale Borough offices will remain closed until further notice due to the rising number of COVID-19 cases.

## Superintendent's Comments - Dr. Joseph Macharola

Dr. Macharola said he has been keeping the Board up-to-date with a lot of information. Quoting John F. Kennedy, he said, "let us not seek the Democratic answer or the Republican answer, but the right answer. Let us not fix the blame for the past. Let us accept responsibility for the future." Dr. Macharola said he could not think of a more applicable quote than that when he thinks of what is coming upon public education across the state and the country, especially in this community. He said one of the things he was going to ask the Board to champion is to get Harrisburg to come on board with cyber legislation to change what is happening to all of the schools in the Commonwealth of Pennsylvania. Dr. Macharola said it is unfair for this school district to pay the amount of money it is required. There are 104 students who are attending external cyber charter schools. He said parents have the choice to do that and he does not mind the choice, but he believes the District does a much better job. Dr. Macharola said it is costing the District taxpayers \$1.568 million. He said he looked at the data and school districts could be in the hole thirteen, fourteen, fifteen, sixteen million dollars. Districts would not be able to operate. Dr. Macharola said one thing the District must look for is cyber school legislation and a change in Harrisburg. He said one thing local politicians could do when out individually - champion the fact that cyber legislation must be changed in Harrisburg. It is hurting the Muhlenberg School District and other districts and that is ridiculous and unfair. Dr. Macharola said it does not equate to the District's per pupil cost or the special education funding. He said local school districts are taking on more of the responsibility for special education funding. The District needs help from the state government and federal government. Dr. Macharola said the District does not know what the revenues will look like; no one in Harrisburg knows right now, but those are

two items that are important to the District. The House and Senate must look at somehow adjusting the cyber school formula in the Commonwealth of Pennsylvania. Dr. Macharola thanked everyone and said steady as she goes...this pandemic will be beaten...continue to trend forward and keep the faith.

# Comments/Questions/Concerns:

Mr. Hoffmaster asked if Dr. Macharola heard anything about the budget coming up that must be voted on in February or March. Will they extend the budget out for the school district? Dr. Macharola replied, the latest information he received was to basically stay tuned; they are looking at the revenues. He said it comes down to two things – revenues and expenditures – and then a balanced budget. Dr. Macharola said he heard they are looking at stimulus dollars, CARES money – how this will be allocated by Harrisburg and there is some hope that something will come from the federal government. He said as far as level funding, that is something that he does not know what it will look like or if it is possible given the revenue status; however, right now, this must be taken moment-by-moment and as this information comes out of Harrisburg the District will handle it.
