#### **Educational Presentations**

Dr. Futrick spoke about the Summer Style Program. He advised this week the District has sent out registrations for the program. Dr. Futrick advised the program will be two four-week sessions in the summer, June 20th to July 14th, and the second session will be July 18th until August 11th. Dr. Futrick talked about the program being four hours a day for the students, providing them with breakfast, lunch, and transportation if warranted. He said there is two different blocks just as done the previous year, one focusing on core academics and one block focusing on some hands-on project based learning; social-emotional learning and another one, Get Involved!, exposing the students to clubs, sports and extra-curricular activities that the District offers. This will kick off in June as Dr. Shappell just sent an email out to the District's entire student body to assure the District's parents are aware of the program. He advised the registration is live and the students have been signing up for it. Dr. Futrick spoke about the KinderCamp being offered this year, as done in the previous year. He explained it is a two-week session done three hours in August; August 1st. August 11th. He advised the District's goal is to capture every incoming kindergarten student for those two weeks, get them started with their teacher that they are going to have and some assistants in the classroom and really get a head start on the school year from that aspect. Dr. Futrick advised the District is very excited about these programs and reported that the registration went live two days ago and already there were over a hundred students within the first few hours. Dr. Futrick said the District's goal is to get over 1500 students this summer signed up for the programs.

**Hearing of Visitors** - Muhlenberg School District taxpayers and residents have an opportunity, at this time, to comment on matters of concern, official action, or deliberation which are or may be before the Muhlenberg School Board. #### **Committee Report**

A. Berks County Intermediate Unit - Mr. J. Tony Lupia, Jr.

Mr. Lupia talked about the BCIU celebration of 50 years of service to the students, families, schools, and the community of Berks County, as well as the Commonwealth of Pennsylvania with a press event held at the BCIU at the main office. The press event was attended by external stakeholders including former BCIU executive director, PDE representatives; federal, state, and local elected officials, school leaders and community partners. During the press event comments were heard from several officials including BCIU Executive Director Dr. Jill Hackman, BCIU Board President Mr. Gary McEwen, previous BCIU Director Dr. K. Robert Hall, Dr. Nancy Allman, Dr. John George, and PDE Deputy Secretary Dr. Sherry Smith from the Office of Elementary and Secondary Education. The following elected officials from federal, state, and local levels also participated in the event to celebrate the BCIU's 50th anniversary. Representative Dan Meuser, PA Senator Judy Schwank, PA Representative Mark Gillen and Ryan MacKenzie, and Berks County's Commissioner's Christian Leinbach and Michael Rivera. Dr. Hackman expressed her appreciation to the Board of Directors, employees, elected officials, schools, and community partners past and present for their continued support and collaboration which are instrumental to the organization's success. He advised it was a wonderful event and they deserve the recognition.

# B. Reading-Muhlenberg CTC - Mrs. Cindy Mengle

Mrs. Mengle advised there was nothing to report as the meeting isn't' until next Monday, however he wanted to welcome Mr. Kahler, Director of the RMCTC, and asked him to speak regarding any updates.

Mr. Kahler reported that they are currently looking at record enrollment for next year as they are very excited about this. He said they were going to see over 540 new students coming to the CTC next year for the first time. He reported this would put their current enrollment just over 1240 students. He advised that they are very excited about ending the year strong and for the next school year. He thanked the Board for their continued support and invited the members to come to the CTC for a visit at any time.

F. Educational Programs - Dr. Alan S. Futrick

Dr. Futrick wanted to take a moment to acknowledge the teacher's hard work they put in every day with the students. They are constantly encouraging, inspiring, and motivating the students. Dr. Futrick advised he believes the District's greatest strengths is the people that work in the Muhlenberg School District. He said he can't say enough for this and thanked the Board for their continued support of the District's staff and giving them the investments and resources they need to be successful.

# Solicitor's Comments - Mr. Brian F. Boland, Esq.

There is no report at this time.

## Superintendent's Comments - Dr. Joseph E. Macharola

Dr. Macharola spoke about the District's administrative assistants, secretaries, the men and women that work in the District's schools, as last week they recognized their assistants. He said he can't say enough about them, they are phenomenal as the District has a wonderful group of employees here and he wanted them to know this; as he welcomed them to a treat. He also spoke to all of the teachers, teachers on the Board that have served and that are currently active, as he mentioned he did sent out a note to the District's teachers that he is very proud of the efforts, of the dedication, and the commitment. Dr. Macharola spoke about the care in the District as continuing to emerge from the last two years of the pandemic; he is very happy with the teaching force the District has here. He talked about being proud of the U.S. News and World Report "stamp" on the Muhlenberg High School. This is a K to 12 accomplishment, every year this District improved. Dr. Macharola talked about the District never having this "stamp" in past and the District has made unbelievable changes; in terms of poverty, in terms of minority students, in terms of transiency, and the District defied all the studies and research out there, because the District did put that "stamp" here. Dr. Macharola discussed an issue over the last two years with the U.S. News and World Report ratings. The District was unfairly, unjustifiably presented wrong in this years and last year's data and evaluations. He advised it was so wrong that it cost the District between 400 and 600 spots nationally and 40 to 60 here in the state of Pennsylvania. He explained what the nominally is; the District is the second highest poverty rate school district in the county. The last two years the U.S. News and World report gave a poverty rate of 40% of the Muhlenberg School District when in fact, the District it was 60% on the data they were using. It is such a faulty mistake, that the District is taking steps to have that corrected. The media already put this out there and he spoke about not appreciating the comments being put out there that there are familiar school districts that are getting recognized for their academic achievement. He spoke about the national summit with other Superintendents he attended; and when he returned he came back with great peace of mind. He advised no school district has done more for their students, more for their staff than the Muhlenberg School District. He advised that he is 99% confident, with peace in his mind, that this District has done more. The District has given opportunities for teachers every Friday for mental health for activities, comradery, the District is supporting the teachers 1000% and there isn't a school district in this state that has done what Muhlenberg School District has done. The programs that this Board has invested, the four pilots that resulted, the millions

of dollars into technology, the investments on the community outreach, the District's social workers that are long overdue; these positions that need to be in here as there is no question about it. The District has continued to invest and keep moving forward. Dr. Macharola spoke about there not being any moment where he, Dr. Futrick haven't continue to work. He spoke about the District not being paid the highest, certainly not the lowest, but not the highest paid. He talked about what he most certainly resented which was data that is being presented out there and suggesting that the Muhlenberg School District is not a top-notch district and if you go somewhere else you are; it's insulting to him and its insulting to the Reading Eagle for putting that out there. He spoke about the District two years in the row has been falsely misrepresented and the District is on record with the U.S. News and World Report to fix this mistake. Regardless of where the District is here, there are 18 school districts and from being in many school districts across the state there are 18 very good school districts in Berks County; to suggest that any one of them is better than the other one is insulting. However, to suggest that the Muhlenberg School District is at the bottom, is even more insulting and he cannot stand for this. He wanted to ask the Board to go out and promote this district for what it is, "one hell of a damn good school district" and the District does everything for the students.

Dr. Macharola received an applause.

# Questions/Comments/Concerns:

Mr. Hoffmaster spoke about since being on the Board how continuously Dr. Macharola "fights" for the Muhlenberg School District; people saw how he fight in 2020 for graduation when nobody wanted to have it, and he took everything. He talked about Dr. Macharola doing a great job, also Mr. Mish and administrators, his heart is in Muhlenberg. Mr. Hoffmaster commented that he knows where Dr. Macharola stands and where his is; he is for Muhlenberg and he is proud of being here.

Mr. Voit spoke about certain people within the community who like to "bad-mouth" Muhlenberg; let's get in their face because Muhlenberg is the place to be.

Mr. Hyneman spoke about being a principal in several different school districts and he had to do with some of the hiring of teachers and he didn't always hire the ones with the highest academic standing, he tried to get a teacher who could connect with the students; who the students would see that is local parentis. He talked about looking back and remembering those teachers that felt like a parent in school, and those are the ones that stayed with you. He talked about this when the District hires people, as it's necessary for those teachers to come in here and look at the students, all of the students, in the classroom as their child.
