We are pleased to inform you that Muhlenberg School District will be implementing a provision known as the Community Eligibility Provision (CEP) in the 2024-2025 school year. This program is available to schools and districts that are participating in the National School Lunch and School Breakfast Programs.

All enrolled students of Muhlenberg School District are eligible to receive a nutritional breakfast and lunch each school day at **no charge** to your household.

No further action is required of you. Your child(ren) will be able to participate in these meal programs without paying a fee or submitting an application.
